Guidelines For Complaints

1. Complaints are to be filed with the Board of Examiners for Land Surveyors and shall be notarized. The Board may initiate a complaint on its own motion.
2. Complaints shall be processed using a number assigned by the Secretary to the Board. The complaints shall be processed by number until formal charges are filed or the complaint is dismissed by the Board.
3. The Secretary shall determine that any supporting documentation filed with the complaint is correct.
4. The Secretary shall present the complaint and supporting documentation to the Board.
5. The Board shall review the complaint and dismiss or direct further investigation.
6. If further investigation is directed by the Board a written check list prepared by the Board shall be presented to the investigative officer.
7. The Board shall appoint a member of the Board to monitor the investigation to insure that the investigation is complete and complies with the request of the Board.

8. The investigative officer shall submit a written report to the Board in compliance with their check list.
9. The Board can determine whether to expand the investigation, dismiss the complaint or order a hearing.
10. If the Board orders a hearing the Secretary, investigator and Attorney General's Office shall prepare a list of charges which shall be approved by the Board. The Board shall appoint a hearing examiner.
