Bolte moved and Whitfield seconded that the Board go into executive session at 9:04 a.m. with Sherlock, Jelkin, and Monahan present to discuss Complaints, and to prevent needless injury to the reputation of a person, and as such person has not requested a public meeting.

Bolte moved and Whitfield seconded that the Board return to regular session at 9:11 a.m.

Whitfield moved and Pro seconded that the Board authorize the Board Chair to sign a settlement agreement dated January 10, 2024 between Buckley D. Blew, LS 763, and the Nebraska Board of Examiners for Land Surveyors.

SETTLEMENT AGREEMENT

THIS AGREEMENT made this 2nd day of January, 2024, by and between the Nebraska Board of Examiners for Land Surveyors (BOARD) and licensee Buckley D. Blew (Blew).

IN CONSIDERATION of a complaint filed against Blew by a member of the public and to resolve any issues between the Board and Blew, the parties agree as follows:

Blew will immediately, voluntarily surrender his license to practice land surveying in the State of Nebraska.

Blew will notify his client, Commercial Due Diligence Services (CDS) that the surveys Blew and his company prepared at the request of CDS for the Project Named "IFC-ROLLING MEADOWS RANCH-NE" do not meet the Minimum Standards for Land Surveys in Nebraska, that the said surveys do not comply with the Rules and Regulations filed under Title 234 of the Nebraska Administrative Code, that the said surveys violate multiple Nebraska State Statutes pertaining to land surveying and are NULL AND VOID in accordance with Nebraska Revised Statute Section 23-1908.

Blew agrees to arrange for the completion of a lawful and proper survey of each tract of land associated with the above-named project by a Land Surveyor licensed in Nebraska in compliance with the laws of the State of Nebraska.

Said licensed surveyor will cooperate with local county officials for the preparation and filing of any necessary corrective deeds where title conflicts have been created by Blew's incompetence.

Blew's licensed surveyor will cooperate with the County Surveyor in each relevant county for the proper and lawful restoration of all lost or obliterated section corners and quarter corners shown as calculated positions on all associated tracts of land.

Blew's licensed surveyor will arrange for the preparation of a separate survey plat of each tract of land in compliance with the Land Surveyors Regulation Act and submit for review a copy of each survey to the Nebraska State Surveyor prior to the official filing of each survey plat of each tract of land separately with the Nebraska Survey Record Repository.

The Chair stated that no subject matter other than land surveying practices, minimum standards for land surveys in Nebraska, and LS (land surveyor) performance reviews, were discussed in the executive session.

Bolte moved and Pro seconded that the Secretary send a letter to the land surveyor (LS) thanking LS for appearing before the Board and appreciated the request to comply with filing of surveys with the State Records Repository (SRR) within 90 days. The Board will review the filing status at their May meeting. Failure to comply and file the surveys with the SRR may result in formal complaint proceedings and jeopardize licensure as a registered land surveyor in the State of Nebraska.

Whitfield moved and Pro seconded that the Secretary send a letter to the land surveyor indicating the Board reviewed their plan of action to correct the survey and looks forward to receiving the filing of the survey with the State Records Repository within 45 days.

Bolte moved and Pro seconded that the Secretary send a letter to the land surveyor noting attention to completing the corrected plat. The Board looks forward to receiving, in a timely matter, the missing and or late filings of the surveys for the State Records Repository as noted in logs previously supplied to the Board. The progress of filing of surveys will be reviewed at the March Board meeting. Failure to file surveys may result in a formal complaint proceeding and jeopardize licensure as a registered in the State of Nebraska.

Whitfield moved and Bolte seconded that the Secretary send a letter to the land surveyor noting the lack of compliance in responding to updating surveys as noted in prior correspondence. Response is requested in 30 days and failure to correct and file the survey in the State Records Repository may result in a formal complaint proceeding and jeopardize licensure as a registered land surveyor in the State of Nebraska.

Bolte moved and Pro seconded that the Board go into executive session at 11:47 a.m. with Sherlock and Monahan present to discuss Complaints, and to prevent needless injury to the reputation of a person, and as such person has not requested a public meeting.

Bolte moved and Pro seconded that the Secretary send a letter to the land surveyor regarding Complaint 23-5, requiring attendance at the March meeting to discuss the complaint. Failure to appear may result in formal action with the filing of formal charges.

Upon receipt of the \$100.00 registration fee, he be granted registration dated January 11, 2024, under Certificate No. 859.

Whitfield moved and Bolte seconded that the Class 2 application of James Harpole for Nebraska land surveyor registration by reciprocity from Illinois be approved and that he be required to appear before the Secretary of the Board for an interview and Nebraska land surveyor examination.

Pro moved and Bolte seconded that since Philip Ryan Horne passed the Nebraska reciprocity examination on December 4, 2023, and has completed the requirements for Class 2 land surveyor

registration in Nebraska, by reciprocity from Pennsylvania, and that upon receipt of the \$100.00 registration fee, he be granted registration dated January 11, 2024, under Certificate No. 860.

Bolte moved and Whitfield seconded that since Christopher Ihde passed the Nebraska reciprocity examination on December 18, 2023, and has completed the requirements for Class 2 land surveyor registration in Nebraska, by reciprocity from Kansas, and that upon receipt of the \$100.00 registration fee, he be granted registration dated January 11, 2024, under Certificate No. 861.

Whitfield moved and Bolte seconded that since Darryl D. Coster took the Nebraska reciprocity examination on December 8, 2023, and has completed the requirements for Class 2 land surveyor registration in Nebraska, by reciprocity from New Mexico, and that upon receipt of the \$100.00 registration fee, he be granted registration dated January 11, 2024, under Certificate No. 862.

Before the formal filing of surveys in the State Records Repository, a newly registered land surveyor is asked to send their first 5 Nebraska surveys to the Nebraska State Surveyor for review. This is a courtesy service to potential unique situations that may arise when surveying in Nebraska.

Pro moved and Whitfield seconded that the Class 3 application of Kirby Duane Andrew Olson for registration by Surveyor-in-Training (SIT) be approved and that since he has demonstrated a knowledge of surveying fundamentals by passing the NCEES Fundamentals of Surveying (FS) examination on October 19, 2023, and upon receipt of the SIT registration for \$20.00, Olson be granted SIT registration dated January 11, 2024, under Certificate No. 305.

Bolte moved and Pro seconded that the Class 3 application of Craig A. Morton for registration by Surveyor-in-Training (SIT) be approved and that since he has demonstrated a knowledge of surveying fundamentals by passing the NCEES Fundamentals of Surveying (FS) examination on May 2, 2023, and upon receipt of the SIT registration for \$20.00, Morton be granted SIT registration dated January 11, 2024, under Certificate No. 306.

The National Council of Examiners for Engineering and Surveying (NCEES) Central Zone Meeting in Des Moines, Iowa, in April was discussed.

Bolte moved and Pro seconded to approve Bolte and Pro as delegates and Sherlock as the Member Board Administrator, to attend the NCEES Central Zone in Des Moines, Iowa in April.
