BOARD OF EXAMINERS FOR LAND SURVEYORS

July 11, 2024

Retiring Board Member Jerry G. Hain, Wahoo, was recognized for his 20 years of service to the Nebraska Board of Examiners for Land Surveyors.

Oath of Office was conducted for new Nebraska Board of Examiners for Land Surveyors member Thomas Tremel of Columbus.

The Nebraska Board of Examiners for Land Surveyors (Board) convened at 9:10 a.m. at 555 N. Cotner Blvd., Lower Level, Lincoln, NE with the following members present:

Public notice of this meeting was given by publication in the *Lincoln Journal Star* on July 1, 2024.

The Chair stated that this meeting was being held in compliance with the updated Nebraska Open Meetings Act (Act) and that a current copy of the Act was available on the table.

All items were voted on in the form of a roll call vote.

Whitfield moved and Pro seconded to approve the May 16, 2024, Board meeting minutes as presented.

Whitfield moved and Pro seconded that the Board go into executive session at 9:14 a.m. with Sherlock, Penry, and Monahan present to discuss Complaints, and to prevent needless injury to the reputation of a person, and as such person has not requested a public meeting.

Motion carried.

The Chair stated that discussion in the executive session would be limited to Complaints.

Whitfield moved and Pro seconded that the Board return to regular session at 9:55 a.m.

The Chair stated that no subject matter other than Complaints was discussed in the executive session.

Feusner moved and Pro seconded that the Secretary draft, with Board approval, a letter to the land surveyor (LS) with the Board's review of the corrective survey/s for issues to be taken by the land surveyor's part for these surveys, other past surveys and all future surveys the LS conducts to meet the Minimum Standards for Surveys in Nebraska.

The Board would like to see more detail on all surveys and corrective surveys, such as an explanation of corrections and procedures followed, to be helpful for future surveys that may be conducted.

Pro moved and Whitfield seconded that the Board go into executive session at 9:56 a.m. with land surveyor, Sherlock, Penry, and Monahan present to discuss Land Surveying Practices, Minimum Standards, and Land Surveyor Performance Reviews and to prevent needless injury to the reputation of a person, and as such person has not requested a public meeting.

Motion carried.

The Chair stated that discussion in the executive session would be limited to land surveying practices, minimum standards, and land surveyor performance reviews.

The land surveyor was dismissed after a discussion with the Board.

Pro moved and Whitfield seconded that the Board return to regular session at 12:09 p.m.

Motion carried.

The Chair stated that no subject matter other than land surveying practices, minimum standards, and land surveyor performance reviews was discussed in the executive session.

Feusner moved and Pro seconded that the Secretary send a letter to the land surveyor (LS) to correct the surveys discussed with the procedures and the methodology in surveys signed and sealed by the LS and file them with the State Records Repository.

The Board will continue to review the land surveyor's surveys and their compliance with the Minimum Standards for Surveys in Nebraska.

Feusner moved and Tremel seconded that the Secretary send a letter to the land surveyor requiring their appearance at the September 12, 2024 Board meeting to discuss their land surveying practices as they pertain to basic survey procedures and methods, proper corner restoration, and the Minimum Standards for Surveys in Nebraska.

The Board took a short break at 12:30 p.m.

The Board discussed survey requirements for boundaries along public highways.

Pro moved and Whitfield seconded that the Secretary send a letter to the person inquiring about requirements for establishing property boundary corners a copy of Minimum Standards for Land Surveys in Nebraska, (H) Monumentation.

According to the Minimum Standards for Land Surveys in Nebraska, (H) Monumentation: The professional land surveyor shall establish, reestablish, or confirm the location of found permanent monuments at each corner or end point on the boundary lines of the parcel or line(s) being surveyed.

The Board discussed well-location surveys.

On March 5, 2024, the Nebraska Legislature passed LB 102. This law provides that, effective September 1, 2024, the penalty for the unlicensed practice of land surveying in Nebraska changes from a Class 1 Misdemeanor for the first offense to a Class IV Felony for the second or any subsequent offense. The Board of Examiners for Land Surveyors (Board) may also impose a fine up to \$10,000.00 for violations of the Land Surveyors Regulation Act. The Board intends to enforce the provisions of LB 102 (2024) relating to the unlawful practice of land surveying in the State of Nebraska by non-Nebraska certified land surveyors.

A revised letter to the Nebraska Oil and Gas Conservation Commission was received from the Assistant Attorney General's office.

Whitfield moved and Tremel seconded that the Secretary send the revised letter to the Nebraska Oil and Gas Conservation Commission referencing "Notice of Intent to Drill or Re-enter".

A response to the Board's May meeting letter regarding local contractors advertising surveying services had not been received. The Board will continue to monitor.

Correspondence from an out-of-state college surveying program was reviewed. The Secretary will send the school accreditation guidelines. The Board does not approve land surveying courses.

Feusner moved and Pro seconded that the Board go into executive session at 1:18 p.m. with land surveyor applicant, Sherlock, Penry, and Monahan present to discuss Class 1 Applications – Land Surveyor, Class 1 Registrations – Land Surveyor, Class 2 Applications – Reciprocity, and Class 2 – Registration - Reciprocity, and to prevent needless injury to the reputation of a person and as such person/s has not requested a public meeting.

The land surveyor applicant was dismissed at 1:51 p.m.
