The Chair stated that this meeting was being held in compliance with the updated Nebraska Open Meetings Act (Act) and that a current copy of the Act was available on the table.

Brent Jorgensen made a presentation to the Board, from 11:08 a.m. to 12:05 p.m., on the status and issues with the National Geodetic Survey (NGS) Conversions. Jorgensen highlighted that the NGS is in the midst of only the second change in calculation to state plane coordinates and geopotential datum in its history, driven by the second major change in calculation of latitude/longitude in history. All elevation determination is from NGS.

NGS also experienced a major reduction in force earlier in 2025. Nebraska is in with 9 other states in a regional advisor system. Most states have some level of geodetic coordinator. Will surveyors continue to work the same way they have, using an established monument, or will they have to establish a new monument?

Bolte moved and Pro seconded that the Class 1 application of Dustin Craig Shropshire for a Nebraska Professional Land Surveyor License be approved, and he is permitted to take the Principles and Practice of Surveying (PS) and Nebraska State-Specific Land Surveyor examinations.

Pro moved and Tremel seconded that since Michael Christopher Ray passed the Nebraska reciprocity examination on November 19, 2025, and has completed the requirements for Class 2 land surveyor registration in Nebraska, by reciprocity from Oklahoma, and that upon a \$100.00 registration fee, he be granted registration dated November 20, 2025, under Certificate No. 877.

Bolte moved and Tremel seconded that inasmuch as Aaron J. Handl, PLS 803, reciprocity from Colorado, has completed the requirements for reinstatement with his Professional Development Hours (PDH) he be approved for licensure upon receipt of the reinstatement fee in the amount of \$220.00 due December 31, 2025. Reinstatement is effective on receipt of payment.

The Board discussed three recent news releases from the National Council of Examiners for Engineering and Surveying (NCEES).

The current Principles and Practice of Surveying (PS) exam will be discontinued after May 31, 2027. A new version will launch in July 2027, with a 6-hour exam and a fee of \$475. This new PS exam will not include PLSS content. A separate Public Land Survey System (PLSS) exam will be introduced in October 2027 and offered twice a year (April and October). The exam will have a 4.5-hour duration and a fee of \$325.

This change will require a Rules and Regulations change to Chapter 4 – Examinations on page 39 of the 68<sup>th</sup> NBELS Annual Report.

NCEES is offering a new Fundamentals of Surveying (FS) interactive practice exam. The exam is available for purchase through the NCEES website.

An Ethics 101 Course will be offered for professional land surveyors and engineers. The course will provide ethics training designed to meet professional development requirements.
